At approximately 4:35 p.m., Nicole Emery, City Clerk, informed the Committee they would be interviewing two applicants for the Tacoma Community Redevelopment Authority (TCRA) Board; five individuals are seeking reappointment, noting staff have requested the committee consider their reappointments based off their prior experience and updated applications; eight positions are available; and the City Clerk's Office did not receive any qualified applicants for the second Attorney position or the CPA position.

The Committee interviewed Joseph Jagod and Jermaine Ogden.

Discussion ensued throughout regarding the applicants' qualifications.

2. [24-0088](#) 2022-2023 Commission on Immigrant and Refugee Affairs Annual Report and 2024 Recommendations  
[Raeshawna Ware, Equity Programs Consultant, Office of Equity and Human Rights]

At approximately 5:03 p.m., Raeshawna Ware, Equity Programs Consultant, Office of Equity and Human Rights (OEHR), provided opening remarks and introduced Natalie Ghayoumi, Vice Chair, Maurice Lekea, Commissioner, Lydia Zepeda, Chair, Maricres Castro, First Vice Chair, Commission on Immigrant and Refugee Affairs (CIRA); and Lisa Woods, Director, OEHR. Together, they presented the 2022-2023 CIRA annual report and the 2024 recommendations, including an overview; background; highlights; community relations; areas of focus, noting the Commission voted to amend its bylaws and submit them to staff for review, and a request for Tacoma Police Department (TPD) to provide trainings and strategies to CIRA; and advocating for reducing barriers that refugees and immigrants face, a proposal on bringing trauma informed policing, and improvement request for blue incident cards that TPD hands out to be available in multiple languages. They concluded by outlining becoming a Certified Welcoming City; welcoming standard; recommendations; questions; and gratitude.

Discussion ensued regarding funding for welcoming week, challenges with funding boards and commissions, certifications and costs, access, services provided, budgeting, membership growth outcomes, welcoming plans based off certification training hour requirements, coordinating meetings, diversity, involvement, statistics on immigration status, resources, recruitment guidelines, language access for the community members for accessing the TPD, legislative process, recommendations to bring to TPD, and the process to go to City Council.




### **Other Items of Interest**
