Human Services Funding Process
[Pamela Duncan, Neighborhood and Community Services]

At approximately 10:03 a.m., Nadia Chandler-Hardy, Neighborhood and Community Services (NCS) Director, provided brief opening comments, and introduced Pam Duncan, NCS. Ms. Duncan provided an overview of the revised human services funding process, including the human services business model, timeline through 2020, defining homelessness and household stability, priority areas, service provider outreach, engagement and training, upcoming systems training sessions, developing sustained contracts and next steps.

Discussion ensued regarding the completion status of the needs assessment, performance of current providers, funding, response to the change in business model, participation in systems training sessions, defining homelessness and household stability, rapid rehousing, percentage of homelessness in Tacoma and Pierce County, support for utilizing a systems based approach to funding, number of homeless individuals in Tacoma, phasing in systems based funding and percentage of homelessness by gender.
