### A. Staff Projects Overview and Updates

The Arts Program is now officially re-named the Office of Arts & Cultural Vitality, and the creation of a permanent full time position for the Public Art Specialist is underway. The Arts and Economic Prosperity survey process is over, and the data will be compiled and reported back officially in July. Funding contracts are in the works for Arts Projects recipients, and calls are now open for Arts Anchor Fund, TAIP, and soon for Tacoma Poet Laureate. Progress on the Kroger mural and the People's Community Center mural was also shared. More traffic box wraps will be created and installed this year in lieu of the Mural Program.

Staff asked for volunteers for the upcoming National Arts Program panel in April, and Commissioners Throne, Conklin, Lacky, and Thompson signed up.
