## **Briefing Items**

3. <u>15-0352</u> Garage Sale Policy Update [Allyson Griffith, Neighborhood and Community Services]

At approximately 4:35 p.m., Allyson Griffith, Neighborhood and Community Services (NCS), provided an overview of today's presentation and reviewed the purpose of garage sales. Dan McConaughy, NCS, reviewed Chapter 6B.160.020 of the Municipal Code related to garage sales, and provided background information on complaints received, Saturday enforcement, removal of hazardous signs, notice of violations and civil

penalties, and 2014 enforcement results. Ms. Griffith concluded by reviewing garage sale information from peer cities, and education and outreach efforts.

Discussion ensued regarding enforcement statistics from 2013 versus 2014, code language regarding who can hold a garage sale and they types of items they can sell, combined garage sales, plant sales, unclear code language and outreach material, the role of the enforcement officer, bike sales, whether there are other code issues that should be addressed before garage sales, additional education and outreach efforts, and providing clear definitions in the code. Council Member Lonergan requested additional information regarding the number of complaints in 2014. Mr. McConaughy stated he will work with Danielle Larson, Tax and License, to address the concerns raised by this Committee. Chair Walker requested staff provide an update to this Committee to include clarifications of definitions, and whether there are other code issues that should be addressed before proactive enforcement for garage sales.

4. <u>15-0353</u> Proposed "Narrowmoor Addition Conservation District"

[Reuben McKnight, Landmarks Preservation Commission]

At approximately 5:00 p.m., Reuben McKnight, Planning and Development Services, reviewed the proposed Narrowmoor Addition Conservation District, including background information, a map of the area, the status of the project, key changes, public feedback and testimony, and next steps. Discussion ensued regarding the proposed district, including feedback from neighbors, how the area aligns with goals under the Growth Management Act as it relates to density, design guidelines, and vegetation in the area. Chair Walker requested a copy of the design guidelines. Deputy Mayor Boe requested information regarding detached accessory dwelling units in the proposed district.

- 5. <u>15-0354</u> Landmarks Preservation Commission Name Change Proposal [Reuben McKnight, Landmarks Preservation Commission]

At approximately 5:31 p.m., Mr. McKnight reviewed the proposal to name an unnamed park after George H. Weyerhaeuser, Jr., including background information and the park location. Discussion ensued regarding whether the park is operated by Metro Parks, and signs that provide information about an individual when a park is named in their honor. Chair Walker requested staff consider the goals of the City, especially those related to equity and empowerment, when reviewing name changes in the City.

MOTION: Deputy Mayor Boe moved to forward the recommendation to name George H. Weyerhaeuser, Jr. Park to the City Council for consideration and approval.

SECONDED BY: Council Member Ibsen.

ACTION: Voice vote was taken and carried. The motion was declared adopted.
