COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Neighborhoods and Housing Committee.

Council Member Walker stated the Neighborhoods and Housing Committee has met twice since the last report and at those meetings the Committee reviewed 2013 accomplishments, including: a review of the Neighborhood Council Program, Code Compliance projects and updates, historic preservation, and neighborhood improvement initiatives. She stated the Committee has developed their 2014 work plan, with topics including temporary homeless camp permit recommendations and other homeless issues, affordable housing recommendations, housing trends, and the state of the neighborhoods. She noted the Committee also recently inteviewed applicants for the Tacoma Community Redevelopment Authority Board and reappointed three current members and recommended three new individuals to serve. She stated the next meeting is on March 3, 2014, at 4:30 p.m. in Conference Room 248, and tentative topics include the Rapid Removal Graffiti Pilot and the Code Compliance windshield survey.

Council Member Ibsen shared several upcoming events, including a Relay for Life event at Joeseppi's Restaurant on Wednesday, February 19, 2014, at 4:00 p.m., a groundbreaking ceremony for The Henry building on Dock Street on Thursday, February 20, 2014, at 8:30 a.m., the next Sister Cities International Film Festival event on Thursday, February 20, 2014, and a town hall meeting for the 27th Legislative District on Saturday, February 22, 2014, at 10:00 a.m. at Jason Lee Middle School.

Council Member Walker invited all to this week's Sister Cities International Film Festival film, Avenue Montaigne, from Biot, France. She stated the movie begins at 7:00 p.m. at the University of Puget Sound, Commencement Hall.
