Briefing Items

1. <u>24-0711</u>

Schuster Parkway Trail Project Update [Basel Kitmitto, Project Manager, Public Works]

At approximately 4:51 p.m., Basel Kitmitto, Project Manager, Public Works, presented the Schuster Parkway Trail project update including an overview; background, noting the preferred alternative; current progress, noting design cost estimates for 2024 and 2027, and consultant scope of work; and next steps.

Discussion ensued regarding total project cost, funding package, lower scope amount, construction costs, costs to cut into the slope of the land, federal support for funding, time frame to 30 percent completion, and stakeholder outreach.

MOTION: Deputy Mayor Hines moved to endorse the scope of work for the Schuster Parkway Trail project to deliver 30 percent design level engineering plans.

2. 24-0712 Accessory Dwelling Unit Update
[Corey Newton, Division Manager, Planning and Development Services]

At approximately 5:13 p.m., Corey Newton, Division Manager, Planning and Development Services, presented the accessory dwelling unit (ADU) update, including applications, noting a positive trend from 2019-2024; ADU permits issued, noting significant increase in permits issued after 2019; permits constructed; and analysis of ADU trends, noting challenges faced, and conclusion and future outlook.

Discussion ensued throughout regarding how the City compares to other cities with approved ADUs; multiple units on one lot; dot map for permit locations; and staff availability for public questions.

4. <u>24-0714</u> "Dr. W. Joye Hardiman Park" Ceremonial Naming Request [Anna Le, Management Fellow, City Manager's Office]

At approximately 5:27 p.m., Anna Le, Management Fellow, City Manager's Office, and Dr. Marcia Tate Arunga, Academic Dean, Evergreen State College Tacoma, together presented the "Dr. W. Joye Hardiman Park" ceremonial naming request, including overview; background; Resolution No. 41009, noting general procedures for roadways; department reviews; parcel location; historical significance of neighborhood; Dr. Hardiman's accomplishments; social and racial equity; outreach; next steps; and recommendations.

Discussion ensued regarding monetary expectations for the sign purchase, presentation of the new name, and who is responsible for the maintenance of the park after the renaming.

MOTION: Deputy Mayor Hines moved the proposed honorary naming of parcel 2004300010 as "Dr. W. Joye Hardiman Park", to the full City Council for consideration.
