SUBJECT: Resolution - Interlocal Agreement for Construction of South Orchard Street Grind & Overlay

(South Orchard Street and Center Street) Between the City of Tacoma and the City of Fircrest

SUMMARY AND PURPOSE:

A resolution authorizing the execution of an Interlocal Agreement with City of Fircrest, in the amount of \$177,992.21, plus a 15 percent contingency, for a total of \$204,691.04, budgeted from 1085 Streets Initiative Fund, for the construction of a joint project on South Orchard Street and Center Street.

BACKGROUND:

This Department's recommendation is based on the poor roadway condition and non-compliant ADA facilities in the South Orchard Street and Center Street intersection. This intersection is a major arterial that provides a vital connection between Tacoma and Fircrest. The cities of Tacoma and Fircrest have completed the design of the improvements, which includes a grind and overlay of the intersection and ADA upgrades. The proposed Interlocal Agreement details roles and responsibilities of each party and outlines the construction cost-sharing breakdown, in which each City is responsible for the costs incurred within their jurisdiction.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Infrastructure improvements identified in this proposed Interlocal Agreement were identified by a significant amount of public engagement and outreach in Tacoma completed to develop the Transportation Master Plan. The outreach included engagement in under-represented neighborhoods where improvements historically haven't met expectations with a goal of identifying opportunities in these neighborhoods and helping assure community members spending is allocated equitably city-wide.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

This proposed resolution will support the City's goals for Equity and Accessibility and Public Works' goals for Access, Traffic Flow and Safety on City streets, and pedestrian facilities. Infrastructure improvements align with Racial Equity Action Plan (REAP) goals to enhance an organizational culture supporting anti-racist actions and equitable infrastructure investment for the improvements, maintenance, and repair of transportation infrastructure in a timely manner affecting all community members requiring access to a variety of different modes of transportation. STAFF/SPONSOR RECOMMENDATION:

The Public Works Department recommends authorization of an Interlocal Agreement with the City of Fircrest to complete the construction of the roadway and pedestrian improvements to the South Orchard Street and Center Street intersection.

This project will be paid for with funds from the 1085 Streets Initiative Fund. The total amount allocated towards the project is \$204,691.04.
