1. <u>16-0266</u> Emergency Response Study & Intelligent Transportation System

At approximately 12:05 p.m., Ian Munce, Planning and Development Services, provided opening remarks on the Tacoma Tideflats Emergency Response Study and Intelligent Transportation System (ITS). Aaron Hughes, Transportation Engineer, Fehr & Peers, provided an overview of the study, background information and discussed the study area and process. He then reviewed the three year emergency response analysis, existing emergency response travel times, roadway network assumptions, and recommended staffing the current Tacoma Fire Department Training Center and re-opening Station No.15. Don Samdahl, Principal and Senior Project Manager, Fehr & Peers, provided a high level summary of the ITS Plan. He then reviewed the existing and planned ITS infrastructure, strategies and goals, short term projects, and next steps. Discussion ensued regarding the plan.
