



## RESOLUTION NO. 39147

1 A RESOLUTION setting April 14, 2015, as the date for a public hearing on the  
2 recommendations of the Community and Economic Development  
3 Department for the City's proposed 2015-2019 Consolidated Plan and  
4 proposed 2015-2016 Annual Action Plan for Housing and Community  
5 Development.

6 WHEREAS the Consolidated Plan for Housing and Community  
7 Development consists of a five-year Housing and Community Development  
8 Strategic Plan and Annual Action Plan, which combines the submission of  
9 applications for Community Development Block Grant ("CDBG"), HOME  
10 Investment Partnership ("HOME"), and Emergency Solutions Grant ("ESG")  
11 funding, and

12 WHEREAS, based on guidance by the U.S. Department of Housing and  
13 Urban Development ("HUD"), the City anticipates that it will be entitled to apply to  
14 HUD for entitlement grant allocations as follows: (1) CDBG, in the amount of  
15 \$2,234,649; (2) HOME, in the amount of \$943,877; and (3) ESG, in the amount of  
16 \$199,158, and

17 WHEREAS the City intends to reallocate \$862,095 in existing CDBG funds,  
18 as set forth in the Annual Action Plan, and

19 WHEREAS, because the City of Lakewood ("Lakewood") does not qualify  
20 to apply for HOME funds independently, the City and Lakewood formed a  
21 consortium in 1999 for the HOME Program, and

22 WHEREAS the City's share of the estimated HOME program grant funds is  
23 expected to be \$765,484, and Lakewood's share is \$178,393, based on last  
24 year's funding allocation, and

WHEREAS, during January and February 2015, the Tacoma Community Redevelopment Authority and Human Services Commission reviewed applications for funding, heard presentations by agencies applying for funding, considered the historic performance of those agencies and the needs of the community, and prepared funding recommendations based thereon, and

WHEREAS the funding recommendations were presented to the City Council at the March 31, 2015, Study Session, and

WHEREAS, before submission of the Annual Action Plan to HUD, the City must fulfill certain citizen participation requirements, including holding a public hearing on the proposed plan, and

WHEREAS the draft Annual Action Plan will be available for public review for a period of 30 days beginning April 1, 2015, and ending April 30, 2015; Now, Therefore,

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:**

Section 1. That Tuesday, April 14, 2015, at approximately 5:30 p.m., is hereby fixed as the time, and the City Council Chambers on the First Floor of the Tacoma Municipal Building, 747 Market Street, Tacoma, Washington, as the place when and where a public hearing shall be held on the recommendations of the Community and Economic Development Department for the City's proposed 2015-2019 Consolidated Plan and 2015-2016 Annual Action Plan for Housing and Community Development.
