Fiscal Impact of IAM&AW District Lodge 160 General Unit Wage Increase for 2012-2016

Overview

This memorandum provides a financial analysis for wage increases for IAM&AW District Lodge 160 General Unit for the years 2012-2016.

Financial Impact

This agreement is for a five year term, 2012-2016, and applies to all classifications in the bargaining unit.

- Effective January 1, 2012 wages shall be increased by 1%.
 - Classifications whose wages are currently reduced due to a pension reduction will be restored to their original salary range. This 1% wage increase will then be applied.
- Effective January 1, 2013 wages shall be increased by 1.5%.
- Effective January 1, 2014 wages shall be increased by 2% as reflected by CPI-W from Seattle-Tacoma-Bremerton, June-June index.
- Effective January 1, 2015 wages shall be increased by 100% of the CPI-W from Seattle-Tacoma-Bremerton, June-June index with a minimum of 2% and a maximum of 4%.
- Effective January 1, 2016 wages shall be increased by 100% of the CPI-W from Seattle-Tacoma-Bremerton, June-June index with a minimum of 2% and a maximum of 4%.

The total estimated cost in 2013-2014 for salaries and benefits including the estimated 2012 estimated retro payout for IAM&AW District Lodge 160 General Unit is \$20,521,716 (\$1,116,645 General Fund, \$7,610,320 General Government Utilities, \$6,816,736 other general government funds, \$4,978,016 Tacoma Public Utilities). The total cost of this negotiated increase is partially included in the 2013-2014 budget.
