 Business License Fees Update

 [Danielle Larson, Tax and License Division Manager, Finance]

At approximately 10:06 a.m., Danielle Larson, Tax and License Division Manager, Finance, provided opening remarks and presented an update on the business license fees, including background, noting Substitute Ordinance No. 28838 passed in December 2022, which established license fees and created a five tier structure, and gross income of the 2022, 2023, and 2024 fees; stakeholder outreach and feedback, noting public safety, homelessness, permitting and zoning, economic development, housing for their workforce, communication, customer service, support for business, and stability and predictability; and staff's recommendations, noting the Committee needs to make a recommendation to the City Council by September 30, 2023, no changes to the 2023 or the 2026 license fees, and tier changes, and that staff will return in about one-year to make recommendations for fee changes in the 2027-2028 biennium.

Discussion ensued regarding the fees for gross income amounts, clarification

on what the bottom tier total and how business license fees affect real estate brokers, Committee support for the recommendations that have been included in the presentation, and a consultant will be selected to create a draft questionnaire for creating surveys that contributes to the gross income and the raise in the business tax and license fees.
