2. 14-0927

Encampment Monitoring and Site Hardening Update [Colin Deforrest, Neighborhood and Community Services]

At approximately 4:33 p.m. Colin Deforrest, Homeless Housing First Coordinator, Neighborhood and Community Services (NCS), stated today's presentation is an update on the City's encampment monitoring and site hardening work, noting many of the City's identified encampment hotspots require site hardening to keep them clear of new activity. He provided background information on the 2013 Revised Encampment Clean-up process and its four phases: identification, clean-up, monitoring, and site hardening; he then provided further details on monitoring and site hardening methods, including positive community monitoring; and fencing, lighting, maintenance of trees and brush and ergonomic diversion techniques. He showed slides of areas with the methods in place, including Swan Creek, Stadium Way, 28th and M Street, 4th Street Bridge, and one of the City's senior centers. Mr. Deforrest concluded with next steps, including monitoring plans for Freighthouse Square, Lincoln Park, the "Jungle Area" project; and site hardening for Dock Street, Delin Street, 34th Street Bridge, and 35th and N Street.

Discussion ensued regarding the City's numbers of homeless, connecting them with services, Crime Prevention through Environmental Design, if any signage is put up with the fencing, and whether NCS works with TPU to take advantage of energy efficiency programs available.

3. 14-0929 Minimum Building and Structure Code Update
[Lisa Wojtanowicz, Neighborhood and Community Services]

At approximately 4:55 p.m. Lisa Wojtanowicz, Division Manager, NCS, stated today's presentation is an update from the last presentation in August, and she is seeking a recommendation from the Committee to move this item forward for full Council consideration.

Ms. Wojtanowicz stated the Minimum Building and Structures Code (MBSC) ensures maintenance of the City's existing buildings. She reviewed the four categories of buildings and goals. She stated staff is recommending a repeal and re-enact of Chapter 2.01 of the Municipal Code. She then reviewed all of the proposed Code revisions in further detail. Ms. Wojtanowicz concluded with next steps, including first reading of the ordinance to amend Chapter 2.01 on October 28, 2014, pending Committee recommendation today. Discussion ensued regarding "initiation of enforcement", under TMC 2.01.050 A. Council Members Boe and Walker suggested Section 2 regarding complaints should be re-arranged to clarify the language. Discussion continued regarding requirements for elevators.

MOTION: Council Member Boe moved to recommend this item to the full Council for consideration with the caveat that he may have to conduct more research on requirements for elevators in 3-story buildings.

ACTION: Voice vote was taken and carried. The motion was declared adopted.
