#### **RECOMMENDATION SUMMARY:**

The Information Technology ("IT") Department recommends contracts be awarded to 22<sup>nd</sup> Century Technologies, Inc., McLean, VA; Infojini, Inc., Columbia, MD; Compu-Vision Consulting Inc., North Brunswick, NJ; Zensa LLC, Redmond, WA; and TEKsystems, Bellevue, WA., each with a contract with a not-to-exceed amount of \$1,800,000, plus applicable taxes, primarily budgeted from IT Department Fund 5800 for an initial contract term of three (3) years with the option to renew for two (2) additional one-year terms, for a projected total value of \$9,000,000, plus applicable taxes, for Temporary Staffing Master Services.

#### STRATEGIC POLICY PRIORITY:

• Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

### **BACKGROUND:**

The IT Department is establishing multiple contracts with qualified firms to provide supplemental support and professional services on an as-needed basis. These services would support the department's service portfolio, which includes Workforce Productivity, Business Automation, Decision Support, Digital Media & Publishing, Technology Operations, Strategy & Portfolio Management, Professional Services and Information Assurance. The IT Department's current master services contracts are due to expire on November 5, 2025.

ISSUE: The demand for experienced technology personnel often exceeds the capacity of City staff. At times, the hiring and contracting processes for specialized IT roles can be lengthy. Having on-call as-needed contracts in place to be able to quickly fill roles allows the IT Department, and other City Departments, to maintain operational stability and respond effectively to service demands.

ALTERNATIVES: Secure temporary staffing through the Requests for Proposal (RFP) process or contracting with specialized vendors as need arises. This would cause severe delays, as this alternative process takes a substantial amount of time.

# **COMPETITIVE SOLICITATION:**

Request for Proposals Specification No. IT25-0021F was opened April 1, 2025. Fourteen companies were invited to bid in addition to normal advertising of the project. Forty-one submittals were received.

Five vendors, 22<sup>nd</sup> Century Technologies, Inc., Infojini, Inc., Compu-Vision Consulting Inc., Zensa LLC., and TEKSystem, LLC, submitted bids that resulted in the highest evaluated submittal after consideration of EIC participation goals. Each vendor will receive their own contract.
