Briefing Items

1. <u>24-0060</u> Historic District Moratorium

At approximately 12:01 p.m., Reuben McKnight, Historic Preservation Officer, Planning and Development Services, provided a brief introduction on the historic district moratorium, including an agenda; overview; summary of review process, noting the public hearing comments and Landmarks Preservation Commission feedback; the Planning Commission recommendation; and next steps.

Council Member Ushka arrived here, at 12:10 p.m.

Discussion ensued regarding support for a historic district moratorium; process and timeline, noting staff capacity and scheduling; expansion or extension of current historic districts and landmarks, including impact on commercial and residential properties; historic districts frequency and benefits; and Landmarks Preservation Commission and Planning Commission administrative processes.

Other Items of Interest

2. 24-0061 Senate Bill 6009 City Council Letter of Support

Council Member Scott presented a Council Consideration Request for a letter in support of Senate Bill 6009 which has been sponsored by Senator Yasmin Trudeau, to prevent police officers from hog-tying, a dangerous, inhumane, and outdated practiced used to restrain an individual. She concluded by stating many metropolitan police departments, including Tacoma, Puyallup, and Seattle, have prohibited hog-tying and a draft letter in support of will be presented at the January 23, 2024, study session.

Discussion ensued regarding thanking Council Member Scott for leadership on the issue, schedule for Senate and House public hearings, noting the draft letter submittal timeline; testimonial, and process; Tacoma delegation co-sponsors; and potential next steps, including walking the letter on at the Council meeting this evening.
