Call to Order

Deputy Mayor Walker called the study session to order at 12:00 p.m.

Roll Call

Briefing Items

1. [23-1035](#) Facility Advisory Committee Final Report

At approximately 12:01 p.m., Nick Anderson, Principal Financial Services Analyst, Office of Management and Budget (OMB), provided a background and overview of the Facility Advisory Committee (FAC) final report, and introduced Nathe Lawver, FAC member, and Jim Dugan, Division Manager, Parametrix Inc. Together they presented an outline; general government facilities, noting why the report was needed; and FAC scope.

Mayor Woodards arrived here, at 12:08 p.m.

Anderson, Lawver, and Dugan they continued with the FAC process overview; criteria and scoring system; prioritized project list, noting public safety facilities that scored highly; additional recommendations, noting leveraging additional funding and continued investment; FAC conclusions, noting success of the process, engagement, and multi-agency collaboration; and next steps.

Discussion ensued regarding street operations facility; appreciation for the FAC members; funding, noting partnerships and collaborations; scoring criteria, noting the maximum score; future of Tacoma Municipal Building, noting a long-term study; deferred maintenance, noting budget policies; facilities footprint in the City; and continued studies, noting operational, design, utilization, and safety. Katie Johnston, Budget Officer, OMB,

concluded the presentation with the revenue strategy, noting guiding principles, timing, and impact; debt limits; financial considerations; and examples.

Discussion continued regarding importance of project prioritization; long term investment in maintenance; decarbonization; Tacoma Public Utility facilities and engagement; general revenue bonds, noting voter approved excess levy; and balance of needs.

2. [23-1036](#) Arts and Economic Prosperity 6 Study Update

At approximately 1:23 p.m., Naomi Strom-Avila, Arts Program Administrator, Community and Economic Development (CED), gave a brief introduction to the arts and economic prosperity study and introduced Lisa Jaret, Arts Program Administrator, CED, and Amanda Figueroa, Tacoma Creates Advisory Board member. Together they presented a study overview; national study findings; Tacoma study data; findings, noting revenue, jobs, tax revenue, event related spending, categories of spending, and social impacts; Tacoma's comparison of economic impacts of spending; and why arts and culture matter.

Discussion ensued regarding participation and appreciation for the study; future leverage and support; partnerships with the Tacoma-Pierce County Chamber of Commerce and Travel Tacoma; event enjoyment; economic impact, noting the median difference in Tacoma's and the cohort population and why; economic development and jobs; and next steps.
