

RESOLUTION NO. 38347

A RESOLUTION relating to City Council election districts; setting
November 1, 2011 as the date for a public hearing to receive comment
on recommended revisions to councilmanic district boundaries following
the decennial census.

WHEREAS, the City Council is required by state law to adjust the boundaries of the five councilmanic districts decennially using the latest United States Census so that the districts meet the criteria outlined in RCW 29A.76.010, including ensuring that district populations remain as equal as possible, and

WHEREAS, the City Council assigned the Government Performance and Finance Committee to consider revisions to councilmanic district boundaries to comply with the requirements of RCW 29A.76.010 following the 2010 Census, and

WHEREAS, the Government Performance and Finance Committee developed and recommended to the City Council a redistricting proposal, and

WHEREAS, RCW 29A.76.010 further requires a public hearing be held concerning any proposed redistricting plan prior to considering it for adoption; Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That the hearing required by RCW 29A.76.010 concerning recommended revisions to councilmanic district boundaries shall commence on November 1, 2011, at approximately 5:30 p.m., in the City Council Chambers, First Floor, Tacoma Municipal Building, 747 Market Street, Tacoma, Washington.



Section 2. That the Clerk of the City of Tacoma shall give proper notice of the time and place of said meeting.
