



ORDINANCE NO. 28442

1 AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the
 2 Tacoma Municipal Code to implement rates of pay and compensation for
 3 non-represented employees and employees represented by the Brotherhood
 4 of Locomotive Engineers and title changes for employees represented by the
 Teamsters Local 117, Tacoma Venues & Events Unit; and declaring the
