SUMMARY AND PURPOSE:

A resolution authorizing Neighborhood & Community Services (NCS) to contract with the vendors listed in Exhibit B for the 2021-22 biennium for a total amount of \$23,061,338. Funding for these contracts will come from a combination of sources, including General Fund, Mental Health & Substance Use Disorder (MHSUD), Criminal Justice, federal Justice Assistance Grant, and COVID funding sources (including Emergency Solutions Grant CARES and WA State Department of Commerce).

BACKGROUND:

To provide stability for providers and ensure continued essential services for the Tacoma community during the COVID pandemic, NCS notified currently funded providers on March 17, 2020, that the City would not require a competitive process to receive funding for NCS contracted services in 2021. After assessing provider needs, and in anticipation of prolonged pandemic impacts, NCS determined that this approach would be carried forward through the 2021-2022 biennium.

NCS staff conducted a review of currently funded contracts and determined allocations for 2021-2022 contracted services based on the following:

- Alignment with Council priorities and department goals
- Commitment to equity and transformation
- Preservation of essential services
- COVID-19 response
- Projected NCS budget
- Program performance in the 2019-20 biennium

NCS staff presented the proposed 2021-22 contract allocations to the Human Services Commission at their November 4th meeting. The Commission formally approved the presentation of the recommendations to the Community Vitality and Safety Committee (CVS).

Staff presented the recommended allocations to CVS at their November 12^{th} meeting with a request for recommendation of approval to the full Council.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Staff has communicated frequently with currently funded providers in order to assess their needs in response to COVID-19 pandemic impacts and their ability to continue providing services. This assessment has included a

provider survey on COVID impacts, requiring program updates to report on how providers have evolved their service provision model to meet COVID restrictions, and virtual contract monitoring conducted by program staff. NCS has worked with providers to ensure contract compliance and continuity of essential services. In response to needs identified, the City provided \$500,000 in US Department of Treasury funding for digital infrastructure enhancements to help programs funded by NCS maintain contracted service delivery levels and compliance with public health guidelines related to COVID-19. This funding placed a particular emphasis on services supporting Black, Indigenous and Persons of Color (BIPOC) communities.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility: (Mandatory)

Programs recommended for funding primarily target and serve underrepresented communities, including BIPOC communities. Systemic racism and racial inequities have resulted in communities of color being disproportionately represented in our populations experiencing homelessness. In 2018, Supporting Partnerships for Anti-Racist Communities (SPARC) conducted a research study to "identify how people are experiencing the accrual of systemic racism" in our community. They found that according to data from the Homeless Management Information System (HMIS) in Tacoma/Pierce County, "Black/African American people represent the HMIS population at a rate of 26.3%, despite only making up 6.6% of the general population in this area." In addition, the Washington State Low Income Housing Alliance reported that "COVID-19 and economic recession threatens significant increases in evictions and homelessness especially among black and latinx renter households." The recommended allocations also include a funding set aside that will be available in 2021 for providers that have never received funding for services in the NCS portfolio, with an emphasis on programs that are serving BIPOC communities and/or are led by BIPOC individuals. NCS will also release a notice of funding availability to expand youth violence intervention and prevention service delivery to provide more culturally relevant approaches to decreasing youth and young adult violence. The goal is to weave together a fabric of services to meet the unique needs of BIPOC communities and neighborhoods and lead to increased awareness, and decreased violence and associated crime involvement. The approach to funding and recommended allocations will advance the NCS Racial Equity Action Plan goals to increase the number of marginalized populations served, build more holistic services to support individuals, and create a means for all providers to easily work together.

Education: *Equity Index Score*: High Opportunity

Increase the number of quality out of school time learning opportunities distributed equitably across the city. All students will graduate from high school and be prepared to enter the workforce or pursue post-secondary education.

Civic Engagement: *Equity Index Score*: Moderate Opportunity

Increase the percentage of residents who believe they are able to have a positive impact on the community and express trust in the public institutions in Tacoma.

Increase the number of residents who participate civically through volunteering and voting.

Livability: *Equity Index Score*: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

Reports of NCS provider performance will be provided quarterly to the Community Vitality and Safety Committee.

Staff recommends approval of the proposed funding allocations. Upon receiving Council approval, NCS staff will finalize and execute contracts with an effective date of January 1, 2021.
