SUMMARY AND PURPOSE:

An ordinance adopting the 2025-2030 Capital Facilities Program (CFP), an amendment of the Comprehensive Plan, and approve the City of Tacoma's 2025-2026 Capital Budget. The 2025-2030 CFP document replaces the previous 2023-2028 CFP.

BACKGROUND:

This Department's Recommendation is Based On:

In compliance with the Growth Management Act, the City Council periodically adopts an updated Capital Facilities Program that indicates existing and proposed capital facilities projects throughout the City of Tacoma. A public hearing was held and the CFP was reviewed by the Planning Commission and recommended for approval.

The Capital Facilities Program helps inform development of the City's Biennial Capital Budget. The Capital Budget was presented at a City Council Worksession on October 8, 2024. Estimates, budgets, notices of hearing(s), hearing(s) and adoption of the Biennial Budget, including the Capital Budget, are processed and accomplished in accordance with the requirements of RCW 35.34. Funds within the Capital Budget are provided with multi-year appropriation and thus must be adopted separately from the Biennial Operating Budget.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The draft 2025-2030 Capital Facilities Program was presented to the Planning Commission on May 1, May 15, June 5, and July 17, 2024, and the public hearing was held on June 5, 2024. The public hearing notice was distributed to individuals and entities on the Planning Commission's mailing list that included the City Council, Neighborhood Councils, business district associations, civic organizations, environmental groups, the development community, the Puyallup Tribal Nation, adjacent jurisdictions, major employers and institutions, City and State departments, and other interested parties. The proposal was posted on the website of the Office of Management and Budget at www.cityoftacoma.org/facilityimprovement. Public hearings were held at the City Council on October 29 and November 19, 2024.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility:

The CFP prioritizes equitable access to City facilities and services as well as maintenance and upgrades to improve equity and accessibility.

Economy/Workforce: Equity Index Score: Moderate Opportunity

Increase the number of infrastructure projects and improvements that support existing and new business developments.

Increase positive public perception related to the Tacoma economy.

Livability: Equity Index Score: Moderate Opportunity

The Capital Facilities Program is a component of the Comprehensive Plan. It aims to align planning processes with financial recourses. The projects included in the CFP include transportation, public buildings, and other public facilities that help achieve important goals in the local economy and livability.

Periodic updates on the status of CFP projects will be provided to the Planning Commission on an as needed basis. The CFP will be reviewed and updated again in 2026 in preparation for the 2027-2032 CFP.

STAFF/SPONSOR RECOMMENDATION:

Staff recommends that the City Council approve the ordinance to update the Capital Facilities Program as an amendment to the Comprehensive Plan, and that the City Council approve the ordinance to appropriate the estimated expenditures and revenues/use of available funds for the Capital Budget for the 2025-2026 biennium, as outlined in Exhibit "A."

FISCAL IMPACT:

The adoption of the 2025-2026 Capital Budget authorizes capital projects and adjusts capital project budgets. There is no fiscal impact, however, for adopting the CFP.
