Government Performance and Finance Committee

Council Member Hines, Chair of the Government Performance and Finance Committee, reported at the May 18, 2021, meeting, the Committee conducted interviews for the Public Utility Board and received a presentation on the Voluntary Employee Beneficiary Association; at the June 1, 2021, meeting, the Committee continued interviews for the Public Utility Board and received presentations on the Environmental Services Commission and Tacoma Creates sales tax revenue; and at the June 15, 2021, meeting, the Committee received presentations on Tacoma Rail, the City's reserve policy, and the first monthly budget update. He concluded by stating the July 6, 2021, meeting, has been cancelled, and the next meeting will be held on July 20, 2021, at 10:00 a.m., through Zoom, and will include presentations on Tacoma Public Utilities' Power Note Purchase Agreement and the monthly budget update.

Council Member Thoms expressed appreciation for the City Council's support of the Helping Individuals Experiencing Homelessness program with Valeo Vocation and shared information regarding program participants and projects, including requests for more hours, site clean ups, and skill development; and conveyed his desire to extend the program later this year.

Mayor Woodards stated that COVID-19 case counts are low, with 28 new cases and one new death in Pierce County; Tacoma is over 50 percent vaccinated; over 40 businesses participated in a six week task force sharing ideas on how to get employees and customers vaccinated; and a group of faith leaders from Tacoma and Pierce County are being convened to discuss how COVID-19 and vaccinations impact their congregations and to provide them with tools to become vaccine ambassadors.
