



## RESOLUTION NO. 41605

1 A RESOLUTION related to the purchase of materials, supplies or equipment, and  
2 the furnishing of services; authorizing the execution of a contract with  
3 Staff Pro, Inc. d.b.a. Allied Universal Security Services, in the amount of  
4 \$19,500,000, plus applicable taxes, budgeted from the Tacoma Dome Fund  
5 and Convention Center and Bicentennial Pavilion Fund, for the provision of  
6 security and guest services at the Tacoma Dome and Greater Tacoma  
Convention Center, for an initial contract period of two years and five  
months, with the option to renew for two additional two-year periods,  
pursuant to Specification No. PF23-0245F.

7 WHEREAS the City has complied with all applicable laws and processes  
8 governing the acquisition of those supplies, and/or the procurement of those  
9 services, inclusive of public works, as is shown by the attached Exhibit "A,"  
10 incorporated herein as though fully set forth, and

12 WHEREAS the \$19,500,000 contract amount reflects the total anticipated  
13 cost for the full six-year, five-month contract period in the event that the contract is  
14 renewed for each of the two, two-year periods, and

15 WHEREAS the Board of Contracts and Awards has concurred with the  
16 recommendation for award as set forth in the attached Exhibit "A"; Now, Therefore,

18 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

19 Section 1. That the Council of the City of Tacoma concurs with the Board of  
20 Contracts and Awards to adopt the recommendation for award as set forth in the  
21 attached Exhibit "A."
