At approximately 4:33 p.m., Doris Sorum, City Clerk, informed the Committee they would be interviewing one applicant for the Board of Building Appeals (BOBA), following the BOBA interviews held at the August 24, 2022, meeting, where the Committee interviewed James Dugan and Konnie Wells, and recommended Wells for the Mechanical/Plumbing Contractor position.

The Committee interviewed Ben Ferguson.

Discussion ensued regarding the applicant's qualifications.

At approximately 4:45 p.m., Mike Carey, Urban Forest Program Manager, Environmental Services (ES), provided opening remarks and introduced Dana Coggon, Executive Director, Pierce Conservation District (PCD). Coggon presented the PCD update, including a history of conservation districts and the Puget Sound; PCD mission and vision; background; work practices; challenges; core programs, noting Harvest Pierce County, environmental education, climate resiliency, and water quality improvement; actions individuals can take to contribute; upcoming volunteer opportunities; and information available online at piercecd.org.

Discussion ensued regarding planting fruit trees and urban gardens in Pierce County.

5. [22-1014](#) Urban Forest Tree Preservation and Food Tree Ordinances
[Ryan Hebert, Urban Forestry Analyst;
Mike Carey, Urban Forest Program Manager, Environmental Services]

At approximately 5:03 p.m., Carey provided opening remarks and introduced Ryan Hebert, Urban Forestry Analyst, ES. Together, they presented proposed Tacoma Municipal Code updates for trees in the right-of-way (ROW), including an overview; background, noting policy review and purpose; background and recommendations for issues, noting food producing trees, ROW tree protections and violations, and code cleanup; and next steps.

Discussion ensued throughout regarding fruit dropping from trees, outreach to pedestrian groups, planting trees in the ROW, caring for trees in the ROW, access to tools and education, the partnership with Harvest Pierce County, caring for sidewalks and mitigating damage caused by trees, distributing fruit harvested from the trees, old growth trees and the tree canopy, Heritage Tree programs, penalty amounts, private property versus the ROW codes, qualifiers for tree removal, and next steps.
