SUBJECT: Ordinance Disclosure

DATE: March 28, 2014

On the agenda for City Council action on April 8, 2014, will be an ordinance to amend the Compensation Plan. This memorandum discloses the contents of that ordinance pursuant to Section 1.12.970 of the Tacoma Municipal Code.

Section 1: Amends Section 1.12.355 to implement provisions of Letters of Agreement negotiated between the City of Tacoma and the Teamsters Local Union No. 117, General Unit. The collective bargaining agreement covers approximately 191.5 full time equivalent (FTE) positions with approximately 141.8 FTE positions assigned within General Government and the remaining 49.7 FTE assigned within Tacoma Public Utilities. The Letters of Agreement were adopted by the Public Utility Board by Resolution U-10681 on March 26, 2014 and are scheduled for consideration by the City Council as a resolution on April 8, 2014.

This section provides for market-based wage adjustments, retroactive to January 1, 2014, based on where each classification in the bargaining unit sits within the comparable market. For employees in classifications that are not receiving a wage adjustment (except for employees in the classification of Laborer, CSC 5001), employees shall receive a 1 percent one time lump sum payment, based on the employee's 2013 base annual salary.

Section 2: Amends Section 1.12.640 to provide employees in the classifications of Crime Analyst (CSC 1101) or Senior Crime Analyst (CSC 1102) with an educational incentive premium of 2.5 percent, when they show proof of a Master's degree in a specialized field, as provided for in a letter of agreement with the Teamsters Local Union No. 117, General Unit. The section will also delete language regarding applications of rate for Grounds Maintenance Worker (CSC 5040), Hydro Grounds Maintenance Worker (CSC 5047) or Street Maintenance Worker (CSC 5002) when operating specialized pieces of equipment as outlined in the letters of agreement. Employees will be eligible to upgrade to the Equipment Operator (CSC 5020) rate of pay in place of the previous applications of rate of 6.2 percent.

Section 3: Provides for the effective dates for the sections above.
