Briefing Items

[Linda Womack, Minority Business Development Agency Tacoma Business Center
Program Director, Community and Economic Development]

At approximately 10:08 a.m., Linda Womack, Minority Business Development Agency (MBDA) Tacoma Business Center Program Director, Community and Economic Development (CED), presented on the MBDA,

including an overview; background, noting program purpose, drivers, core clients, and core deliverables; Tacoma Minority Business Enterprises (MBEs) results; regional results; Tacoma-based businesses by industry and ethnicity; regional clients by ethnicity and industry; services provided and spending; success stories; and economic impacts. She concluded by reviewing services that support Tacoma Women and MBEs, a list of MBEs, and future opportunities.

Discussion ensued regarding the roles of the MBDA program compared to Small Business Enterprise, Local Employment and Apprenticeship Training, and other programs; organizational and staff changes to support programs; outreach efforts; past and future Council discussions and actions; the City's disparity study; ways Council can help promote businesses in the program; and encouraging growth in other industries, such as information technology.

Citywide Parking Services Overview

[Eric Huseby, Operations Manager, and Dana Brown, Assistant Division Manager, Public Works]

At approximately 10:43 a.m., Dana Brown, Assistant Division Manager, Public Works (PW), provided opening remarks and introduced Eric Huseby, Parking Services Manager, PW. Mr. Brown presented on Citywide Parking Services, including an overview; best practice approaches; a history of parking issues in Tacoma, focusing on downtown parking; and parking fund debt obligations. Mr. Huseby outlined guiding principles; relationship with the Parking Technical Advisory Group; on-street parking; enforcement; and off-street municipal facilities. Mr. Brown concluded by reviewing upcoming plans.

Discussion ensued throughout regarding supply and demand; impact of Commute Trip Reduction programs and private facilities; City policies, standards, and obligations; underserved areas; costs to provide parking and impacts on development; number and location of City parking facilities; safety and public perceptions; impacts of private development, transit projects, and events; new mobile apps; enforcement related to infractions and Court processes; customer-friendly enforcement methods; collaboration with CED efforts; goal to keep street parking available; and areas for study.
