1. Call to Order 5:05 pm (00:00)

3. Chair's Report/Housekeeping

(03:57)

Chair Shakoor shared that Jamika Scott is the new City Council Liaison for the Tacoma Arts Commission. She also acknowledged that February is Black History Month and thanked African American ancestors for work they have done to develop a framework for civil rights.

4. Public Comment on Agenda Items

(05:06)

There were no public comments on agenda items.

5. Action Items

a. Larchmont Concrete Stamps Final Design

(06:05)

Staff gave an update about the Larchmont Concrete Stamp public art project that Saiyare Refaei has been developing. Staff shared the 17 design drawings as well as a mock-up of how the pieces would look along the street.

Staff shared an overview of the proposed approach for sharing the project digitally via Storymaps, with particular focus on accessibility. The proposal includes ability for viewers to use a screen reader, inclusion of alt text for images, video and audio clips, and Spanish translation across the platform. Staff also discussed approaches for sharing out the project through local partners.

6. Discussion/Updates

a. Division Manager Recruitment

(39:30)

Commissioner Joe Williams shared about the recruitment process for the Division Manager of Arts & Cultural Vitality. Nine semi-finalists were selected from the original applicant pool and two finalists are moving on to final interviews where they will give a presentation and answer questions. A limited number of Commissioners who RSVP will have an opportunity to attend the next round of interviews and provide feedback about the two candidates.

b. Subcommittees and Sign-Ups

(44:35)

Staff gave an overview of each subcommittee and their relationship to the Commission.

AMOCAT Arts Awards Subcommittee

This is a short-term subcommittee that will review and make recommendations about the current awards, structure, review process, and public award event. Commissioners Neal, Takla, and Fernandez-Llamazares volunteered to serve on this subcommittee.

• Tacoma Arts Month Subcommittee

This is a short-term subcommittee that will help shape Tacoma Arts Month programming. Staff will collect volunteers for this subcommittee later in the year.

• Funding Subcommittee

This is a short-term subcommittee that will look at the Commission's current funding programs, funding distribution levels, and consider updates for 2025-26 funding cycle. Vice Chair Brown and Commissioners Joe Williams and Kula volunteered to serve on this subcommittee.

Public Art Subcommittee

This is a short-term subcommittee that will be working on the public art work plan. Vice Chair Brown and Commissioners Behe and Hoppe volunteered to serve on this subcommittee.

Diversity, Equity, & Inclusion Subcommittee

This is an ongoing Commissioner-led subcommittee that looks at how to support the needs of the cultural community through a DEI lens. Work includes discussions as well as application to real Commission projects and programs. Chair Shakoor, Vice Chair Brown, and Commissioners Takla, Kula, Gilmore, Neal, and Wygle volunteered to serve on the subcommittee.

c. Council Coffee – Overview, Goals, Approaches

(58:40)

Chair Shakoor shared about her experience doing Council Coffee meetings last year. Staff gave an overview of the City Council districts and what districts each City Council member represents. Staff gave an overview of the purpose of the meetings, how to sign up for the meetings, the meeting format, and the support documents including an outline of talking points and the Arts & Cultural Vitality Division's annual report. Commissioners shared out about their past experiences and tips for Council Coffee meetings.

- Contracting with Tacoma Public Schools to do a public art project with Oakland High School
- Environmental Services' 'If it hits the ground, it hits the sound' campaign, which included public art components, won a national award

c. Tacoma Creates

Staff gave an overview of the 2024-2025 Tacoma Creates funding cycle; Tacoma Creates Impact Funding and Comprehensive Organizational Support applications are due in March. Funding application workshops are being held.

State partners are looking to Tacoma as an example of how to roll out Cultural Access funding at the local level. The Tacoma Creates initiative will need to be reauthorized and work is being done with City Council to prepare for this.
