SUBJECT: Resolution - Department of Commerce Public Facility Improvement Fund Grant Acceptance

**DATE:** April 15, 2024

#### **SUMMARY AND PURPOSE:**

A resolution authorizing the execution of an agreement with the Department of Commerce in the amount of \$3,000,000, budgeted from Fund 4170, for reimbursement of expenses associated with capital repairs and improvements to Cheney Stadium from July 1, 2023 to June 30, 2027.

#### **BACKGROUND:**

This Department's Recommendation is Based On: A \$3,000,000 grant was awarded by the Department of Commerce through its Public Facility Improvement Fund to the Baseball Club of Tacoma, LLC d/b/a Tacoma Rainiers with the City of Tacoma serving as Fiscal Agent. This grant will support required critical repairs to Cheney Stadium bowl seating area to meet safety standards and improvements to locker room spaces to comply with MLB Requirements to maintain affiliate status.

#### **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

The Baseball Club of Tacoma, LLC d/b/a Tacoma Rainiers, undertook emergency repairs to the Cheney Stadium seating bowl in 2023-2024 to ensure public safety and continued operating ability for the facility. Simultaneously, Major League Baseball updated certain infrastructure requirements to maintain the Tacoma Rainiers MLBi Designation. These requirements necessitated updates to the visiting team locker rooms, also undertaken in 2023-2024.

The City is contractually obligated to pay for all such capital improvements as part of the lease agreement with the Baseball Club of Tacoma, dated December 31, 2009. The Tacoma Rainiers and the City's Government Affairs team collaborated to successfully obtain \$3,000,000 in funding to cover approximately 2/3 of the cost of these capital improvements.

#### **2025 STRATEGIC PRIORITIES:**

Equity and Accessibility: (Mandatory)

Maintaining safe guest access to Cheney Stadium and retaining the Tacoma Rainiers MLBi affiliation is critical to continuing to ensure ongoing access to reasonably priced entertainment and sporting events for all members of our community.

**Economy/Workforce**: *Equity Index Score*: Low Opportunity

Increase the percentage of people relocating to the city and affordability of housing compared to neighboring jurisdictions.

**Livability:** *Equity Index Score*: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

# Explain how your legislation will affect the selected indicator(s).

A thriving entertainment and cultural sector is critical to enhancing livability of the City of Tacoma and is a strong tool to encouraging families to relocate to the city. Conversely, a major venue that has become non-functional and derelict due to lack of capital investment creates an area of blight within the community that is not welcoming to new residents or out of town visitors. This project will help ensure the ongoing sustainability of Cheney Stadium and its impact on the City of Tacoma livability.

Staff recommends that Council adopts a resolution authorizing the acceptance of the grant funds from the Department of Commerce. Staff anticipates that funds will be available upon Council's authorization.
