Small Business Loan Programs and Loan Portfolio presentation [Carey Jenkins, Housing Division Manager, Community and Economic Development; Jacinda Howard, Contract & Program Auditor, Community and Economic Development]

At approximately 10:03 a.m., Carey Jenkins, Housing Division Manager, presented an overview on the Small Business Loan Programs and Ioan portfolio. Mr. Jenkins stated small business Ioan programs are managed by the Housing Division staff of the Community and Economic Development

Department (CED). He reviewed the current loan programs, including the Business Fçade Improvement Loan Program, Historic Rehabilitation and Repair Loan Program, Fire Safety Loan Program. He reviewed funded loans in the past 18 months for façade improvements and funding partner loans. He stated a memorandum of understanding (MOU) with Craft3 has been signed to market small business economic development loans. He concluded that the next steps are to update and revise the Economic Development Administration, Title IX Administrative Plan, continue marketing loan programs, the MOU with Craft3, and work with new underwriters. Walter Acuna, Vice President and Business Lender for Craft3, reviewed the difference between Craft3 loans and other loan programs.

Discussion ensued regarding Craft3 options, differences between loans and what is available to different types of businesses.
