Chair O'Loughlin called the Public Utility Board study session to order at 3:00 p.m. in the third-floor conference room (LT1) of the Public Utilities Administration Building.

Residential Customer Satisfaction Study Update

Holly Lucht, Customer and Data Analytics Manager, summarized the survey methodology utilized for this study. Ms. Lucht reviewed the survey results for the following categories for each of the operating divisions: Overall satisfaction with TPU; Being a trusted organization; Promptly fixing customer problems; Having friendly/courteous employees; Value of electric service; Reliability of electric service; Value of water service; and Reliability of water service. Results for bill affordability and the ability to pay bills were then reviewed. Ms. Lucht concluded the presentation by sharing the national utility benchmarking; TPU remains in the top quartile and is 9th of 102 utilities in overall satisfaction.

Customer Experience and External Affairs Annual Update

Shana Williams, Asst. Customer Services Manager, shared the challenges and accomplishments by CS in 2025. Some accomplishments include expanded customer feedback channels, multilingual lobby surveys, and extended lobby hours. Statistics for customer assistance impacts, customer satisfaction survey, performance metrics, lobby and in-person channels, arrears trending, and MyAccount trending were reviewed.

Guiding Principle on Resource Sustainability and Stewardship

The Board discussed the possible inclusion of language concerning economic development in this Guiding Principle (GP) and motions that may be brought forward during the evening meeting as this is a regular meeting agenda item.

Public Utility Board Self-Evaluation

Chair O'Loughlin introduced the concept of the Board conducting a self-evaluation and a 360-degree review. Discussion ensued. The proposal will be refined and brought back for discussion at a later time.

Board/Director Comments/Updates

Board Members reported on and made positive remarks about events attended since the last meeting that included MLK Day events, Howard Hanson Dam event with Senator Patty Murray, and the Chamber's annual Horizons Economic Forecast breakfast.

The executive session was adjourned at 5:44 p.m.

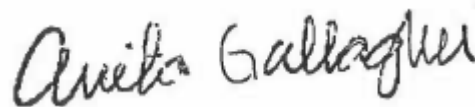
