Business Tax – Service tax to the good by \$4.6M, pulled down by Cable TV Tax (-\$1.7M), and Natural Gas Tax (-\$1.3M)

- Carry-over savings for obligated costs from prior year into new biennium
- · Adjusting existing commitments
- Adjusting for corrections and new information

Re-Appropriation Summary

Total Increase in 2025-2026 General Fund Expenditures: \$21 M

- January Budget Adjustment Clean Up (\$2.8 M)
 - Removal of negative expense placeholder offset by increased B&O and GET Tax Revenue
- Third Party Liability Correction (\$9.2 M)
 - Needed contributions for Police, Public Works, and Fire third party liability
- Delays and Obligations (\$10.1 M)
 - The Rescue Mission Expansion, Shelter Transition & Decommissioning
 - Affordable Housing Development delays, Participatory Budget Expense carryover
 - · Housing Accessibility Infrastructure
 - TPL carryover
 - Various PDS contract commitments
 - In-car video delay, TPD equipment replacement
- Corrections (-\$1.1 M)
