



## RESOLUTION NO. 39465

1 A RESOLUTION relating to the vacation of City right-of-way; setting Thursday,  
2 August 4, 2016, at 1:30 p.m., as the date for a hearing before the City of  
3 Tacoma Hearing Examiner on the petition of Skookum Holdings, LLC, to  
4 vacate a portion of the alley between East 25th Street and Puyallup Avenue,  
lying between A Street and Interstate 705, for a private driveway.

5 WHEREAS Skookum Holdings, LLC, having received the consent of the  
6 owners of more than two-thirds of the properties abutting a portion of the alley  
7 between East 25th Street and Puyallup Avenue, lying between A Street and  
8 Interstate 705, has petitioned for the vacation of the following legally described  
9 right-of-way area:

11 That portion of the Northeast quarter of the Northwest quarter of  
12 Section 09, Township 20 North, Range 03 East, W.M., more  
particularly described as follows:

13 The alley abutting Lots 5 & 6, inclusive, Block 7515 and Block  
14 7416, Tacoma Land Company's First Addition to Tacoma W.T.,  
15 according to the plat filed July 7, 1884, records of Pierce County  
Auditor;

16 EXCEPT that portion for Interstate 705.

17 Situate in the City of Tacoma, County of Pierce, State of  
18 Washington.

19 Now, Therefore,

20 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

21 Section 1. That Thursday, August 4, 2016, at 1:30 p.m., is hereby fixed  
22 as the date and time, and the Council Chambers on the first floor of the  
23 Tacoma Municipal Building, 747 Market Street, in the City of Tacoma, as the  
24 place when and where said request will be heard by the Hearing Examiner and
