### Community Vitality and Safety Committee

Council Member Blocker, Vice Chair of the Community Vitality and Safety Committee, reported at the September 8, 2022, meeting, the Committee conducted interviews for the Tacoma Area Commission on Disabilities and

received a presentation on the 2023-2024 Mental Health and Substance Use Disorder funding process and recommendations; and on September 22, 2022, the Committee received a presentation on an anti-displacement strategy. He concluded by stating the next meeting will be held in a hybrid format on October 13, 2022, at 4:30 p.m.

Council Member Rumbaugh described the significance of Rosh Hashanah and Yom Kippur, noting she would not be attending the October 4, 2022, City Council meeting because she will be observing Yom Kippur; and wished the Jewish community Shana Tova (a Happy New Year) and a sweet new year.

Mayor Woodards informed everyone that Tacoma Reads Together is an annual Citywide literary partnership with the Tacoma Public Library, noting books are chosen for ages of all readers in the City; it's a season of free literary events at public libraries and throughout the City; each season of Tacoma Reads Together has a theme, and this year's theme is hope, resilience, and community; and the reading selections reflect these themes. She continued by stating the children's selection is by author Oge Mora, entitled "Thank you Omu!"; the youth-adult selection is by author Cookie Hiponia, entitled "We Belong"; and the adult selection is by author Julia Alvarez, entitled "Afterlife". Mayor Woodards concluded by inviting everyone to attend the Little Literary Fest at the Tacoma Public Library Moore Branch on Saturday, October 1, 2022, for workshops and live performances; the celebration of Filipino American Heritage Month on Saturday, October 8, 2022; and a virtual event on Saturday, November 5, 2022, where she will be interviewing author Julia Alvarez; and to find more information on these events, go to [tacomalibrary.org/tacomareads](http://tacomalibrary.org/tacomareads).
