### **Briefing Items**

1. <u>24-0322</u> Comprehensive Plan Update

[Steve Atkinson, Principal Planner; Maryam Moeinian, Senior Planner, Planning and Development Services; Carrie Wilhelme, Principal Transportation Analyst, Public Works]

At approximately 12:00 p.m., Steve Atkinson, Principal Planner, Planning and Development Services (PDS) provided a brief overview on the Comprehensive Plan update; agenda; and introduced Maryam Moeinian, Senior Planner, PDS; Carrie Wilhelme, Principal Transportation Analyst, Public Works; and Alyssa Torrez, Senior Planner, PDS. Moeinian provided context to what the Comprehensive Plan is, noting a shared vision, and role of the City; planning context, noting the projected amount of new residents, jobs, and homes; and what has been happening, noting engagement planning and community profile. Atkinson continued with the scope of work, noting growth management, Vision 2050, and local initiatives; and focus areas and policy elements. Wilhelme presented the Transportation Master Plan, noting correlation with the Land Use Plan and key items for the update; and guiding vision. Torrez concluded with engagement analysis, noting universal alignment; proposed plan; project timeline and engagement integration and tools; workshop design; and ways to participate.

Discussion ensued regarding appreciation for the collaboration including plans and engagement; Vision Zero; priority policy focus areas, noting safety and green hierarchy; event participation and plan variation for community events, noting what feedback community members have given; best ways for Council Members to provide feedback, noting the City's committees, boards, and commissions meetings; growth metrics; conflicts and collaborations between jurisdictional boundaries and other agency's comprehensive plans; and housing, noting growth and budget requirements for the amount of new residents.

#### 2. <u>24-0323</u>

East Portland Avenue Project - Request for Eminent Domain [Susie Rogers, Principal Real Property Officer; Josh Lauer, Engineering Project Manager, Public Works; Steve Victor, Deputy City Attorney, City Attorney's Office]

At approximately 1:02 p.m., Susie Rogers, Principal Real Property Officer, Public Works (PW) provided an overview of the East Portland Avenue Project at East 56th and East 64th Streets, and project funding; and East Portland Avenue right-of-way needs, noting remaining parcel hold-out, existing conditions, proposed improvements, and next steps.

Discussion ensued regarding appreciation for the numerous ways staff took to reach out to the property owner; next steps, noting the upcoming Council vote; issues; and future potential projects.
