



## RESOLUTION NO. 40695

1 A RESOLUTION relating to human services; authorizing the execution of  
2 agreements with multiple vendors, in the total amount of \$24,061,338,  
3 budgeted from a combination of various funds, for the period of January 1,  
4 2021, through December 31, 2022, to provide stability for providers and  
ensure continued essential services for the Tacoma community during the  
COVID-19 pandemic.

5 WHEREAS, in order to provide stability for providers and ensure continued  
6 essential services for the Tacoma community during the COVID-19 pandemic, the  
7 City's Neighborhood and Community Services ("NCS") Department notified  
8 City's Neighborhood and Community Services ("NCS") Department notified  
9 currently funded providers on March 17, 2020, that it would not require a  
10 competitive process to receive funding for NCS contracted services in 2021, and

11 WHEREAS NCS staff has communicated frequently with currently funded  
12 providers in order to assess their needs in response to COVID-19 pandemic  
13 impacts and their ability to continue providing services, and

14 WHEREAS, after assessing provider needs and in anticipation of prolonged  
15 pandemic impacts, NCS has determined that this approach would be carried  
16 forward through the 2021-2022 biennium, and

17 WHEREAS, after conducting a review of currently funded contracts, NCS  
18 staff presented the proposed 2021-2022 contract allocations to the Human Services  
19 Commission ("HSC") at its meeting of November 4, 2020, and the HSC formally  
20 approved presentation of the proposed recommendations to the Community Vitality  
21 and Safety Committee ("Committee"), and

22 WHEREAS NCS staff presented the proposed funding allocations to the  
23 Committee at its meeting of November 12, 2020, and the Committee recommended

that the proposed allocations be forwarded to the City Council for its consideration,

1 and

2 WHEREAS the proposed funding allocations support programming across a  
3 diverse array of services, including aging and disability; community; homeless  
4 outreach; homeless supportive services; housing and shelter; transformation and  
5 equitable service delivery; violence reduction; wellness; and youth development,  
6 and

8 WHEREAS these programs primarily target and serve underrepresented  
9 communities, and the proposed allocations also include funding that will be  
10 available in 2021 for providers that have never received funding for services in the  
11 NCS portfolio, with an emphasis on programs that are serving Black, Indigenous  
12 and Persons of Color ("BIPOC") individuals and communities, and  
13

14 WHEREAS NCS will provide notice of funding availability to expand youth  
15 violence intervention and prevention service delivery to provide more culturally  
16 relevant approaches to decreasing youth and young adult violence; Now,  
17 Therefore,

19 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

20 Section 1. That the proper officers of the City are hereby authorized to  
21 enter into agreements with multiple vendors, in the total amount of \$24,061,338,  
22 budgeted from a combination of various funds, for the period of January 1, 2021,  
23 through December 31, 2022, to provide stability for providers and ensure continued  
24 essential services for the Tacoma community during the COVID-19 pandemic, all  
25 as more specifically set forth in the attached Exhibit "A."
