## Call To Order

Chair Ushka called the meeting to order at 4:35 p.m.

## Roll Call

**Present:** 4 - Blocker, Daniels, Rumbaugh and Ushka

## Briefing Items

- [22-0610](#)** Firearms and Ammunition Tax  
[Andy Cherullo, Director; Danielle Larson, Tax and License Manager, Finance]  
  
At approximately 4:37 p.m., Andy Cherullo, Director, Finance, provided opening remarks on the City's proposed firearm and ammunition tax, and introduced Eric Madfis, Associate Professor of Criminal Justice, University of Washington Tacoma (UWT). Madfis provided introductory remarks and introduced Randy Myers and Jeff Cohen, Associate Professors of Criminal Justice, UWT. Cruz presented evidence-based principles and practices for youth gun violence prevention and intervention, including increased crime and violence in Tacoma; and the evidence-based principles, noting the importance of community-led, trauma-informed, restorative, and holistic principles. Myers outlined community-based prevention and intervention; and successful and promising practices for prevention and intervention, noting hospital-based violence intervention, employment programs for young people, and early intervention programs for young children and their families. Cohen continued by reviewing successful and promising practices in schools, noting restorative school discipline, "whole-school" approaches, and trauma-sensitive schools. Hawes and Cruz concluded by outlining next steps.

Discussion ensued regarding progress the City has made; available statistics of expelling and suspending students from school; grants; public safety officers in schools and how its seen as a deterrent; restorative versus punitive actions; gun violence response at the general level; generating funding, support, and outreach for organizations dealing with gun violence issues; the use of the firearm and ammunition tax revenue; the demographics covered by youth gun violence; and the role of Tacoma Public Schools.

Cherullo then presented on the firearms and ammunition tax and community engagement, including an overview; background; and issues, noting an executive summary of community feedback, and major themes of community feedback.

Discussion continued regarding the sample size of the survey, opportunities to conduct the survey again, how events can change people's opinions, patterns of violence within the City, recent state and federal action regarding gun violence, and historic gun sale patterns.

Council Member Daniels stated that she attended the Mayor's Youth Commission meeting, where the Commission discussed youth safety, addressing gun violence, and increased violence during the summer months.


## Adjournment
