#### REPORTS BY THE CITY MANAGER

City Manager Elizabeth Pauli introduced Joe Franco, Special Assistant to the Director of Public Works. Franco provided an update on the City's American Public Works Association (APWA) reaccreditation efforts, noting Public Works and Environmental Services were granted full accreditation by the APWA for the third time through 2027, detail of what the accreditation formally verifies and recognizes, what the process is designed for, the APWA accreditation team evaluated both departments on 396 individual practices and identified two model practices that were considered the best in the country, and the benefits of receiving the accreditation.
