



## RESOLUTION NO. 39565

1 A RESOLUTION relating to the vacation of City right-of-way; setting Thursday,  
 2 December 1, 2016, at 1:30 p.m., as the date for a hearing before the City  
 3 of Tacoma Hearing Examiner on the petition of the Puyallup Tribe of  
 4 Indians, to vacate a portion of the alley lying between East 28th and  
 5 East 29th Streets, between Portland Avenue and East "R" Street, abutting  
 and adjacent to Puyallup Tribal property, for a new multi-level garage  
 structure, casino, hotel, and restaurant.

6 WHEREAS the Puyallup Tribe of Indians, having received the consent of  
 7 the owners of more than two-thirds of the properties abutting a portion of the  
 8 alley lying between East 28th and East 29th Streets, between Portland Avenue  
 9 and East "R" Street, have petitioned for the vacation of the following legally  
 10 described right-of-way area:

All that portion of alley right-of-way lying between and  
 abutting Blocks 7846 and 7945 of Map of the Indian Addition  
 to the City of Tacoma, as per plat recorded in Volume 7 of  
 Plats at Pages 30-31, records of Pierce County, Washington,  
 lying Easterly of the Easterly margin of Portland Avenue and  
 Westerly of the West line of Lot 24 of said Blocks 7846 and  
 7945.

Situate in the City of Tacoma, County of Pierce, State of  
 Washington; within Section 10, Township 20 North,  
 Range 03 East of the Willamette Meridian.
