### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Government Performance and Finance Committee

Deputy Mayor Hines, Chair of the Government Performance and Finance Committee, reported the April 16, 2024, meeting was cancelled; at the special meeting on April 23, 2024, the Committee received a monthly budget update, and a presentation on proposed water rate additions to Tacoma Municipal Code Chapter 12.10; and the May 7, 2024, meeting included presentations on short-term rentals, Planning and Development Services fee schedule updates, and the Tacoma Public Utilities residential customer satisfaction study. He concluded by stating the next meeting will be a joint Audit Advisory Board held in a hybrid format on May 21, 2024, at 10:00 a.m., and will include Public Utility Board interviews, the Moss Adams 2023 audit exit conference, and the State Auditor's Office 2022 accountability audit exit conference and 2023 financial audit entrance conference.

Infrastructure, Planning, and Sustainability Committee

Council Member Walker, Chair of the Infrastructure, Planning and Sustainability Committee, reported the meeting on April 10, 2024, included Landmarks Preservation Commission interviews, and proposed amendments to the parking enforcement code; the April 24, 2024, meeting included a presentation on the City's residential and commercial Call-2-Haul program, noting a proposal to expand the program to multi-family units; and that the May 8, 2024, meeting has been cancelled. She concluded by stating the next meeting will be held in a hybrid format on May 22, 2024, at 4:30 p.m., and will include Planning Commission interviews, and a presentation on options to increase deconstruction and salvage efforts.
