# REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax thanked community members and staff who attended the Project PEACE culminating event last night at the Greater Tacoma Convention and Trade Center. He stated the meeting provided staff an opportunity to share information collected from the community conversations during the five meetings held in September and October of last year. He further stated 30 items were identified for future consideration and action by the City and the Tacoma Police Department as a result of the prior conversations and online comments shared by residents. He highlighted several items and stated in the near future staff will be outlining timelines and next steps.
