Briefing Items

1. <u>23-0197</u> Downtown Tacoma Partnership Annual Update [David Schroedel, Executive Director, Downtown Tacoma Partnership]

At approximately 10:02 a.m., David Schroedel, Executive Director, Downtown Tacoma Partnership (DTP), presented an update on the DTP, including background; DTP leadership; the 2017 Business Improvement Area (BIA) survey; the 2023-2024 DTP BIA budget; and 2022 results, noting safety, graffiti removal, and welcoming posts on Instagram. He concluded by describing photographs of past events that DTP have sponsored; COVID-19 storefronts, noting openings and closings; and news headlines from 2023.

Discussion ensued throughout regarding graffiti tag repeat offenders, DTP funding, a business climate survey, the decrease in demand for office spaces, the usage of rooftop spaces, who administers DTP elections, storefront closures due to the retirement of business owners, the demographics of those living in Downtown Tacoma, potential green spaces in the City, the Link light rail, the cost benefits of residential

versus office spaces, amenities for residential tenants, DTP leadership, and the expansion of DTP.

23-0198 Spaceworks Tacoma Update
 [Michael Liang, Program Director; Jennifer English, Training Coordinator, Spaceworks Tacoma]

At approximately 10:51 a.m., Michael Liang, Program Director, Spaceworks Tacoma, provided opening remarks and presented an update on Spaceworks Tacoma, including images of community members that Spaceworks Tacoma serves; the creation of Spaceworks Tacoma, noting program areas of artscapes, coworking space, and the incubator; wraparound support for creative entrepreneurs, noting training, funding, community, and space; current City of Tacoma funding; key partners; and key initiatives for fiscal year 2023. Jennifer English, Training Coordinator, Spaceworks Tacoma, concluded by presenting on the Home Incubation Agreement, including who needs home incubation, background, a comparison of the current policy and proposed changes; and a summary.

Discussion ensued regarding the submission process for policy proposals, and a food incubator.
