Points of Interest Not Reflected in PowerPoint:

- -Poverty rate in Tacoma for children is 26%, higher than Pierce County or Washington state, higher than seniors.
- -1 in 2 children who are African American living in Tacoma are in poverty.
- -Tacoma Public Schools has a higher rate of homelessness than our neighboring districts.
- -Finding that young adults aged 17-34 earning under \$50k/year feel the least safe in Tacoma.
- -Marijuana use in youth in Tacoma is higher than other communities in the state.
- -Tacoma residents have a higher rate of violence than elsewhere in the state, in particular with domestic violence.
- -20% of homeless from Point of Time count have experienced domestic violence.
- -Good portion of the community in Tacoma does not have purchasing power, and as the housing market is further stretched that lack of buying power will only increase.

Questions from HSC:

- -The exclusion of Hispanic families from the needs assessment seems problematic.
- -Single female head of households experience poverty at a greater rate, how is that accounted for or addressed?
- How much of the THA families/population make up the poverty in Tacoma?

- -Request for data to understand THA's client group and what its makeup is in Tacoma's population in poverty

The City recognizes there is an opioid epidemic, synthetic marijuana use, and methamphetamine use issues are areas of opportunity not currently being addressed with rigor.

Additional, there are great opportunities around work force development.
