## Call to Order

Mayor Woodards called the meeting to order at 12:09 p.m.

## Briefing Items

1. [19-0788](#) Disparity Study, Priority Hire and I-1000 Update

At approximately 12:09 p.m., Tadd Wille, Deputy City Manager, introduced Clifford Armstrong, Program Manager, Community and Economic Development (CED), and Steve Victor, Deputy City Attorney, and made opening remarks on the disparity study on equity in contracting and local workforce development, including desired outcomes and objectives. Together, Mr. Armstrong and Mr. Victor presented the current policies; historical context; recommendations, including phase I: implement foundational recommendations and consider code and policy changes, phase II: implement major policy advancements, and phase III: evaluate, learn, adjust, and revise; and next steps.

Discussion ensued regarding future updates and data to bring back to the City Council; State pool versus City contractor and supplier pool, benefits, and risks thereof; the process of getting onto the contractor and supplier list; and evaluation priorities for contractors within the City.

2. [19-0789](#) Affordable Housing Action Strategy Update

At approximately 12:47 p.m., Jeff Robinson, Director, CED, and Tanisha Jumper, Director, Media and Communications (MC), made opening remarks on the Affordable Housing Action Strategy (AHAS) update. Jacques Colon, Strategic Manager, MC, presented the tactical teams; the

AHAS implementation milestones; inclusionary zoning; the Multi-Family Property Tax Exemption (MFTE); displacement risk versus access to opportunity; current stock of MFTE units in relation to those numbers; the BERK Consulting analysis, noting the current scenario, the 12-Year MFTE only, and inclusionary zoning; the feedback summary from the latest tactical advisory group regarding inclusionary zoning and the MFTE; surplus land policy; capital improvements; and diverse housing types. Daniel Murillo, Housing Division Manager, CED, reviewed the Affordable Housing Trust Fund. Mr. Colon concluded by reviewing the streamlined permit review process, derelict housing, owner occupied housing repair, tenant protections, resources for housing and rental assistance, and next steps.

Discussion ensued regarding Substitute House Bill 1406, construction in the Tacoma Mall area, using census tracked data for the MFTE and geographic specificity, looking at rent changes by neighborhood versus the entire City, funding construction, use of the trust fund, and qualifications for housing repair loans.
