3 A RESOLUTION appointing individuals to committees that will prepare  
4 statements "For" and "Against" Proposition No. 1, concerning utility taxes  
5 and property tax levy rate for street improvements, which will appear in  
6 the Voters' Pamphlet for the Tuesday, April 22, 2025, Special Election.

7 WHEREAS on December 17, 2024, the City Council adopted Resolution  
8 No. 41588, placing a proposition concerning utility taxes and property tax levy  
9 rate for street improvements (Streets Initiative II), on the ballot for the  
10 April 22, 2025, Special Election, and

11 WHEREAS, per the Revised Code of Washington 29A.32.280, for each  
12 measure from a unit of local government that is included in a local voters'  
13 pamphlet, the legislative authority of that jurisdiction shall, not later than the  
14 resolution deadline, formally appoint a committee to prepare arguments  
15 advocating voters' approval of the measure, and shall formally appoint a  
16 committee to prepare arguments advocating voters' rejection of the measure,

20 reviewed letters of interest at their regularly scheduled meeting on Tuesday,  
21 January 21, 2025, and provided recommendations for the appointment of  
22 individuals for the "For" and "Against" Committees for the proposition; Now,
