**SUMMARY:**

Requesting authorization to ratify the existing Interlocal Cooperation Agreement and execute an amended Interlocal Cooperation Agreement for use in distribution of funds and allocation of resources pursuant to the 2018 Washington Auto Theft Prevention Grant Award.

**BACKGROUND:**

Local Law Enforcement entities recognized a need for proactive regional cooperation to address the problems created by auto theft within the region and determined that a concentrated and coordinated effort is critical to an effective statewide response to vehicle theft and have agreed to provide mutual aid and share resources as necessary.

The parties to this Agreement are the Washington State Patrol, Pierce County Sheriff’s Office, King County Prosecutor’s Office, and the Municipalities of Auburn, Bonney Lake, Federal Way, Lakewood, Puyallup, Redmond, Tacoma, Tukwila, and the Port of Seattle, each of which is a state, county, or municipal corporation operating under the laws of the State of Washington.

**ISSUE:**

Auto Theft is a regional problem.

**ALTERNATIVES:**

The alternative would be to address auto theft within our city without the grant funding and cooperative assistance of local law enforcement agencies.

**RECOMMENDATION:**

Recommend approval to execute the amended Interlocal Agreement.
