

RESOLUTION NO. 41681

BY REQUEST OF COUNCIL MEMBERS HINES, RUMBAUGH, SCOTT, AND WALKER

A RESOLUTION authorizing the one-time use of funds in the amount of \$10,000, budgeted from the Council Contingency Fund, for sponsorship of Tacoma Porchfest 2025.

WHEREAS Tacoma Porchfest ("Porchfest") is a beloved community festival that has been growing steadily since its kickoff in 2022, drawing an estimated 8,000-10,000 attendees in 2024, with anticipated continued growth for 2025, that will take place in Central Tacoma (south of 6th Avenue) and North Tacoma (north of 6th Avenue), and will be free for the public to attend, and

WHEREAS Porchfest offers a unique experience that pairs musicians and performers with porch stages and private yards, embedding the festival experience into neighborhoods and activating new relationships and community through conversations and meaningful connections around a shared love of music and performance art, and

WHEREAS Porchfest's mission is to build community, celebrate the City's neighborhoods, and connect neighbors through a free, walkable, and accessible celebration of diverse live music and performances in a six by six block festival zone, where attendees have the opportunity to meet neighbors, take pride in their neighborhood, and experience performances they may not usually encounter, and

WHEREAS every genre of music is welcome at Porchfest, from "main act" bands to amateurs, and will also feature non-music performances such as stand-up comedy and poetry readings, drawing in artists from all walks of life, and



WHEREAS one street of the festival zone will be closed off to traffic to allow for a family-friendly activity street administered by local youth development-focused organizations, and

WHEREAS Porchfest also helps advance a number of goals and priorities outlined in several of the City's strategic plans:

- (1) Porchfest aligns with several of the priorities of the City's ArtFull Tacoma strategic plan, including increasing participation in arts and culture, embracing the City's diversity, strengthening arts and cultural assets, and will help drive the City's creative economy as well, especially by enabling musicians and performers to reach new audiences and network amongst each other;
- (2) Porchfest advances key goals in the City's Economic Development

 Strategic Plan, including expanding economic gains for local businesses by

 activating and bringing thousands of people from across the City and beyond to the

 6th Avenue area; and
- (3) Porchfest advances several of the City's livability and community building goals outlined in the Tacoma 2025 framework, including nurturing community by fostering connections that are made when neighbors walk into each other's yards and introduce themselves and by inspiring yard sales and block party-style cookouts during the festival, and

WHEREAS the City's sponsorship would be acknowledged through the use of the City's logo on advertising and promotional materials, and Porchfest is also offering the City an opportunity to host a resource booth at no charge during the

festival, which would allow City staff to connect with thousands of festival attendees to share resources and information about City services, and

WHEREAS, at the April 29, 2025, Study Session, Council Member Scott shared a Council Consideration Request to authorize the one-time use of \$10,000 from the Council Contingency Fund for sponsorship of Tacoma Porchfest 2025, and

WHEREAS City staff will negotiate and execute an agreement for services, with terms and deliverables for the City's investment, and

WHEREAS RCW 35.34.250 and 35.34.260 authorize a withdrawal from the Council Contingency fund for any municipal expense, the necessity or extent of which could not have been foreseen or reasonably evaluated at the time of adopting the budget, and

WHEREAS Ordinance No. 22569 requires an affirmative vote of not less than six members of the Council in order to withdraw moneys from this fund; Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That the foregoing Recitals are hereby adopted as the City Council's legislative findings.

Section 2. That one-time funding in the amount of \$10,000, budgeted from the Council Contingency Fund, is hereby approved for the purpose of supporting the Tacoma Porchfest 2025.



Section 3. That the proper officers of the City are hereby authorized to	
confirm deliverables with Tacoma Porchfest 2025 for the purposes hereinabove	
enumerated, and document as ap	propriate.
