COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Chair Mello stated the Committee has met three times since the last report. He stated on April 9, 2014 the Committee heard an update on the North Vassault Sidewalk project and the development of Tacoma's Transportation Master Plan, including the project time line and proposed public involvement plan. He noted residents should expect to see community outreach efforts going on this summer. He stated on April 23, 2014, the Committee heard about various sustainability efforts going on throughout the city, including sustainable

materials management, green roads, and a new green events program for large events. He added the Committee heard the proposed 2014 comprehensive annual amendments to the Comprehensive Plan, which will come to Council as a public hearing on June 3, 2014. Finally, he reported on the meeting of May 14, 2014, noting Public Works presented on operational initiatives being planned for on- and off-street parking, and Sound Transit presented on the Tacoma Link expansion including time line, community outreach options for station stops, and the status of funding to complete Tacoma Link expansion. He stated the next meeting is scheduled for May 28, 2014, and the Committee will conduct interviews for vacancies on the Sustainable Tacoma Commission.

Council Member Ibsen stated the Weatherly Inn is hosting a free public gala for State Senator Rosa Franklin this Thursday at 4:00 p.m. He stated Senator Franklin is a great champion for the City of Tacoma and for working families, noting she is currently working on many projects, including the Asia Pacific Cultural Center. He invited everyone to attend the event in honor of her service.

Council Member Boe stated it is still Bike Month and highlighted a number of upcoming events in celebration of Bike Month. He invited everyone to attend the events and to visit www.bike253.com for more information. He then invited everyone to attend the next downtown walk on architecture, held May 21, 2014, reminded everyone the farmer's markets are now open, and stated Tacoma Little Theater is doing an amazing production of Bye Bye Birdie.

Council Member Walker stated the Hilltop Diversitree Program is going strong, noting there was an anonymous donation of \$100,000 to plant up to 200 trees in the Hilltop neighborhood. She stated trees are being planted around the Safeway area and there will be medians between South J Street and South Sheridan on South 11th Street, adding it is exciting to get more trees in this beautiful urban area and to help with increasing the tree canopy.

Council Member Campbell stated on Monday there will be a rededication of the Ray C. Roberts Memorial Park at the corner of McKinley Avenue and Morton Street. He stated this has been a long neglected park in the city and it will be cleaned up with a new memorial. He invited everyone to attend the ceremony at 3:30 p.m.

Council Member Lonergan stated a community cleanup will be held on May 31, 2014 at Jefferson Elementary at 10:00 a.m. and community members can drop off debris, help clean up right-of-ways, and recycle metal and tires. He then stated Sunday, June 1, 2014 is the first day of the South Tacoma Farmer's Market at the STAR Center.

Deputy Mayor Woodards stated she had the privilege of attending the United Way's annual community celebration and Tansy Hayward accepted the 2013 campaign of the year award on behalf of the City of Tacoma. She thanked staff at the City and at United Way for their efforts, noting employees doubled their contributions from 2012 to 2013. She then congratulated Council Member Mello and his partner Jerry who were joined in marriage on Saturday.

Deputy Mayor Woodards reminded everyone the May 27, 2014 City Council study session and business meeting are cancelled and the next regularly scheduled meetings will be on June 3, 2014.
