Ordinance - Amending Tacoma Municipal Code Chapter 3.09 to adopt Building

Inspection Fees to take effect on June 1, 2015

### **SUMMARY:**

An Ordinance amending Chapter 3.09 of the Tacoma Municipal Code (TMC), adding a new section, 3.09.050 for inspection fees, and renumbering Section 3.09.050 to .060 and other various sections, the Fire Code of the City of Tacoma, that regulates hazards to life, property, and the environment within building occupancies or premises within the City of Tacoma and providing for code enforcement inspections of buildings of various industrial, commercial, and multifamily uses and therefore adopting new fees to be assessed for building inspections.

### STRATEGIC POLICY PRIORITY:

Passage of this ordinance will further the Council's Strategic Policy Priority to "strengthen and support public safety, human services, public education, and diverse higher learning opportunities in Tacoma."

### BACKGROUND:

The Tacoma Fire Department (TFD) performs periodic code enforcement inspections of buildings, in accordance with the adopted Fire Code, to protect people, property, and the environment. This fire and life safety code compliance program is one of TFD's fire prevention activities that helps improve the overall safety of our community by reducing the risk of fires and hazardous materials incidents. The routine inspections identify and correct fire code violations, educate business and property owners about fire and life safety issues, reduce fire loss, which helps keep insurance rates low, and provide less demand on public emergency services. TFD plans to enhance the inspection program by improving scheduling, training of personnel, and online payments as the Accela Fire module is activated.

### **ISSUE:**

Given the desire to reduce the City's dependence upon federal grants to maintain TFD staffing, TFD proposes that a fee be charged for building inspections to help offset inspection costs. The proposed fees will not fully fund the inspection program.

## **ALTERNATIVES:**

If the ordinance is not adopted, TFD will be unable to charge for building inspections, resulting in an estimated General Fund reduction of \$450,000 for 2015–2016.

### **RECOMMENDATION:**

TFD recommends approval of this ordinance to begin assessing fees for building inspections.
