

ORDINANCE NO. 28228

AN ORDINANCE relating to the Compensation Plan; amending Section 1.12.355 of the Tacoma Municipal Code; and declaring the effective dates thereof to implement rates of pay and compensation for employees represented by the United Transportation Union, Switch Crew Unit.

WHEREAS the collective bargaining agreement with the United

Transportation Union, Switch Crew Unit ("Union"), was approved pursuant to

Resolution No. 36584, adopted on July 19, 2005, and covers approximately

32 budgeted, full-time equivalent positions, and

WHEREAS the agreement provides for cost-of-living adjustments based on 90 percent of the Consumer Price Index of Urban Wage Earners,

Seattle-Tacoma, CPI-W, April and October indexes, to be applied at six-month intervals until a new agreement is reached, and

WHEREAS the CPI-W index for the April-to-April period was 2.6 percent, and

WHEREAS, pursuant to the terms of the agreement, all classifications will receive a 2.3 percent increase effective July 1, 2014, and

WHEREAS City Council authorization is required to implement rates of pay and compensation within the collective bargaining agreement that has been negotiated with the Union on behalf of its represented employees; Now, Therefore,
