RE: Jail Services Contract Extension to June, 30, 2015

Dear T.C.:

The purpose of this letter is to outline the conditions under which Fife agrees to the request by Tacoma to extend the termination date of Fife/Tacoma Interlocal Agreement for Jail Services by one month from May 30th, 2015 to June 30, 2015 with a Transition Plan through July 31, 2015, as stated below. The extension shall be subject, to the following conditions:

1. Transition Plan:

- a. Bookings and Municipal Court Transports for Tacoma inmates by Fife shall terminate on June 30, 2015.
- b. Transport of inmates to the Tacoma Municipal Court in the months of June and July will have a 50% surcharge added to the base transport rate.
- c. (i) Sentenced inmates shall remain in Fife's custody until they serve their sentences; OR
(ii) Tacoma at its sole discretion may transfer inmates remaining in Fife's custody to another agency of its choice by July 31, 2015 provided that it obtains any required judicial orders approving the transfer to the new facility, and (2) it provides Fife with at least 48 business hours notice prior to the date of transfer.
- d. Tacoma agrees to pay for the inmates in Fife's custody during the transition period, including the day of transfer, based on the rates below.

2. Rates:

The following billing rates shall apply for Tacoma inmates booked with Fife as of March 1, 2015:
