SUMMARY:

Tacoma Rail recommends a contract be awarded to Midvale Electric, Inc., in the amount of \$739,095.00, plus applicable sales tax, for Mountain Division highway-rail grade crossing signal maintenance and inspections, for an initial contract term of three years with the option to renew for two additional oneyear terms for a cumulative contract amount of \$1,231,825.00.

STRATEGIC POLICY PRIORITY:

The contract supports public safety and is necessary to maintain compliance with existing federal regulations prescribed within 49 CFR Part 234 which outline highway-rail grade crossing signal systems inspection and maintenance routines with the objective of reducing collisions at these crossings.

Strengthen and support public safety, human services, public education, and diverse higher learning opportunities in Tacoma.

BACKGROUND:

Tacoma Rail Mountain Division (TRMW) has 239 federally registered highway-rail grade crossings, 46 of which are signalized. Of those, 31 remain the responsibility of the Mountain Division after recent divestments of segments of the territory.

The determination as to which crossings are signalized is made by the Washington Utilities and Transportation Commission (WUTC), based on statistical analysis of data using a complex matrix. The WUTC owns the installed grade crossing signal equipment as typically installation costs are covered by federal Section 130 funding. However, once a signal system is installed, the railroad has inspection and maintenance responsibility in perpetuity until such time that the WUTC would approve a formal petition filed by the railroad requesting the removal of an existing grade crossing signal system.

ALTERNATIVES: There are no practical alternatives for this service contract, as Tacoma Rail does not currently employ staff with the technical expertise necessary to effectively inspect and maintain the grade crossing signal systems, and a substantial investment in training, vehicles, tools, and materials would need to be made in order to internalize this activity.

COMPETITIVE SOLICITATION:

Request for Bids Specification No. TR14-0166F was opened May 27, 2014. Three companies were invited to bid in addition to normal advertising of the project. One submittal was received. The table below reflects the amount of the initial award.

Pre-bid Estimate: \$625,000.00

The recommended award is 18.4 percent above the pre-bid estimate. Tacoma Rail's pre-bid estimate was based on the previous contract amount plus a five percent escalator.

CONTRACT HISTORY: New contract.

SUSTAINABILITY: This service contract will help ensure ongoing compliance with existing federal regulations and contribute to public safety. All replaced or antiquated materials are routinely recycled.

SBE/LEAP COMPLIANCE: No bids were received from Small Business Enterprise (SBE) contractors for this Single Trade project. The Local Employment and Apprenticeship Training Program (LEAP) goal is not applicable.

RECOMMENDATION:

Tacoma Rail recommends a contract be awarded to Midvale Electric, Inc., for routine inspection and maintenance of TRMW's grade crossing signal systems. If approved, the effective dates of the contract are from July 1, 2014 through June 30, 2017, with the options for two additional one-year extensions.
