1. [24-0965](#) 2024-2029 Stormwater Permit and Stormwater Manual Updates

Deputy Mayor Hines arrived here, at 4:36 pm.

At approximately 4:36 p.m., Shauna Hansen, Principal Civil Engineer, Environmental Services, and Joy Rodriguez, Principal Civil Engineer, and Mieke Hoppin, Civil Engineer, Planning and Development Services, presented the municipal stormwater permit and manual updates, including an overview; and permit update main themes and significant changes, noting new mapping, operations and maintenance requirements, code updates, next steps, urban tree canopy, and climate change impacts. They concluded with Stormwater Manual updates, including highlights; permit mandate, noting required changes; redevelopment thresholds, noting commercial and

industrial projects, and road-related projects; other non-mandated updates; the revision process, noting the public engagement schedule; and next steps.

Discussion ensued regarding City Council decision points, integration with Home in Tacoma, stormwater system development charges, tree canopy goals, development for the Tideflats Subarea Plan and the Puyallup River, and the stormwater comprehensive plan.

2. [24-0966](#) Puyallup Tribe of Indians Honorary Roadway Naming Request
[Brennan Kidd, Assistant Division Manager, Public Works]

At approximately 5:09 p.m., Brennan Kidd, Assistant Division Manager, Public Works, presented the Puyallup Tribe of Indians roadway naming request, including an overview, noting this is the first naming request from the Puyallup Tribe; background, noting the Tribe's companion website for more information; sample locations and proposed names; examples of existing location mock-ups; honorary road renaming procedures; departmental reviews; outreach; next steps; and recommendations.

Discussion ensued regarding the cost for the honorary signage, and reaching out to the City's Media and Communications Office to spotlight the honorary naming.

MOTION: Council Member Diaz moved to forward the proposed honorary naming for various roadways and intersections within the 1873 survey area of the Puyallup Reservation to the full City Council for consideration.
